Fern Bacon Middle School holds an annual Title 1 / Back to School Night during the school year. This parent informational meeting is held at the beginning of the school year to promote parent involvement, needs assessment, and feedback. In addition, parent involvement and feedback is solicited during SSC, ELAC, and parent meetings throughout the year.

Fern Bacon Middle School offers parent meetings during the school day and after school. Fern Bacon provides translators and meeting agendas in both English, Spanish, and Hmong.
