Program Goals:

- The major goal of this agreement is to enable the student to keep current with his/her grade level studies for the period covered by this STIS Agreement.
- All objectives are consistent with curriculum guidelines as established by the SCUSD.
- Homework assignments for the student will be specific for each subject covered. Specific objectives for this student's STIS are listed on page 3 of the Agreement.
- Assignments will represent approximately 20 hours of homework each week for grades K – 12.

Terms and Conditions of Short Term Independent Study Agreement

Student: I understand that Short Term Independent Study is a voluntary program and I agree and understand that:

- I will meet with my teacher every week at the appointment time on my Agreement.
- One missed weekly appointment is the same as being 5 days absent from school.
- I will be marked absent if my homework is not done.
- I will be marked absent if I do not keep my teacher appointments.
- Being absent from school can prevent me from promoting to the next grade.
- If I have two missed appointments or do not do my home work, I may have to return to regular school

I agree to all conditions of the STIS Agreement. In addition, I also understand that:

- Short Term Independent Study is a voluntary program that must be agreed upon by the student, parent/guardian and the home school administrator.
- The independent study teacher appointments are for the teacher to meet with the student and to evaluate and measure the student's academic progress and schoolwork on a timely basis.
- It is my responsibility to promptly reschedule a teacher appointment in case of emergency.
- Two or more rescheduled appointments may result in termination of this Agreement.
- I am responsible for supervising the student while he/she is completing the assigned schoolwork and for ensuring the completion and submission of all assignments on time.
- The Independent Study Agreement may be terminated if the student :
 - A. Misses Teacher's appointment; and/or
 - B. Turns in Incomplete Assignments (assignments are considered incomplete if the work submitted is unsatisfactory; F grade)
- I am responsible for transportation to and from scheduled teacher appointments.
- If materials are lost, stolen, or forgotten, it is my responsibility to immediately contact the school at the phone number on this Agreement and make arrangements to replace materials at my own expense. Replacement may involve faxing, overnight mail, or e-mail transmissions or some other expedited service.
- STIS Agreements that are terminated may result in the student being marked absent for all, or part of the Agreement period, depending upon the effective date of termination.
- The number of days absent from school has the same result for independent study students as it does for other students going to regular school.
- Absences may affect the student's return to the home school and/or promotion to the next grade level.
